



RELEASE AND WAIVER OF LIABILITY FOR VOLUNTARY PARTICIPATION IN THE USE AND ENJOYMENT OF INFLATABLE TRAMPOLINES

I further attest that neither I nor my minor child or children suffer from any heart, lung, musculoskeletal, or other medical condition or disease that might in any way hinder or prevent me or my minor child or children from fully and safely participating in the use and enjoyment of the ITs. I acknowledge that my and/or my minor child or children's participation in such activities is completely voluntary and that I and/or my minor child or children may elect to continue or discontinue participation at my sole discretion. **INITIAL:** _____

In consideration of my and/or my minor child or children's participation in the use and enjoyment of the ITs, I hereby release, discharge and hold harmless NMAC and its officers, directors, employees, members, instructors, agents, successors, and assigns from any and all liability that may arise, directly or indirectly, now or in the future, by reason of any injury, damage, loss, or expense incurred in connection with my and/or my minor child or children's participation in the use and enjoyment of the ITs, including that caused solely or in part by the fault (including but not limited to negligence, gross negligence and/or recklessness) of the above-named parties. This Release and Waiver of Liability shall be binding on my heirs, executors, administrators, successors, and assigns. - NO jewelry/sharp objects permitted inside inflatables
- FEET FIRST down every slide
- NO adults permitted inside inflatables
- NO ROUGH PLAY, ANYWHERE
- NO FLIPS/TUMBLING, ANYWHERE
- NO RUNNING, ANYWHERE
